- 5. You hereby grant to me and anyone authorised by me all consents which may be required under the Copyright Designs and Patents Act 1988 (and any other applicable law in the world) to use the Performance in accordance with the terms of this Release.
- 6. To the extent permitted by applicable law, you hereby waive all, and agree not to assert any, moral rights, performers' rights and all similar or equivalent rights anywhere in the world now existing or created in future which you may have in relation to the Performance.
